In the rare occurrence that The Knowledge Company cannot provide an expert in a given field or in a given field within the time frame selected, we will inform the contact on the case in a timely fashion. Should The Knowledge Company cease work on an evaluation because an expert is not available, we reserve the right to charge a consultation fee based on time spent on the case, at the Standard or Expedited rate depending upon the service selected.

**Our Independent Experts:** All experts render their opinions according to the standards of their discipline and profession. Our experts' opinions meet the USCIS standards for recognized authority. They include the determination of equivalency to a specific bachelor's degree or master's degree. All reports of The Knowledge Company and expert opinions included therein are strictly advisory to all organizations and to the client. Translations should be certified as follows: "I certify that I am fluent in both English and [foreign language] and that the attached English translation of [applicant's name]'s [document's name] is a true and accurate translation of the original document(s) in [foreign language]." The translator needs to sign this statement and initial any attached pages. We will not accept translations by the client. When there are time constraints, The Knowledge Company will evaluate documents in the original language for the following: Chinese, French, German, Italian, Portuguese, Russian, and Spanish. For this service we charge an additional \$22 per degree. Documents in languages other than those listed above **must** be accompanied by certified translations.
